# About the Region

The Greater Sullivan County Public Health Region is one of 13 New Hampshire public health regions. This region includes the following 15 rural towns and one city with a combined population of approximately 47,000 people: Acworth, Charlestown, Claremont, Cornish, Croydon, Goshen, Langdon, Lempster, Newport, Springfield, Sunapee, and Unity in Sullivan County and Newbury, New London, Sutton, and Wilmot in Merrimack County. There are two community hospitals located in the region: Valley Regional Hospital on the western edge of the region in Claremont and New London Hospital in

the eastern part of the region. The priority updates in this report include initiatives led by the Public Health Advisory Council (PHAC) and community partners.

# Public Health Advisory Council

Chair: Catherine Bardier, New London Hospital

The Public Health Advisory Council (PHAC) consists of community leaders representing multiple sectors and towns/cities throughout the Public Health Region. In early 2019, the PHAC welcomed a new chair, Catherine Bardier, and reviewed our regional priorities based on the most recent Community Health Needs Assessments and newly available data for our region. We always welcome new partners to the table. We meet on the first Wednesday of each even month from 9:00-11:00 AM in the Buckley Conference Room at Valley Regional Hospital but switched to meeting virtually in Spring of 2020 when COVID-19 hit the region.

The Community Partners Meeting (CPM) is hosted in partnership with the Greater Sullivan County Public Health Network, Southwestern Community Services, and Service Link. The CPM aims to connect community-based organizations in a roundtable discussion and resource sharing. The Public Health Advisory Council (PHAC) utilizes the CPM to disperse information throughout the community on topics that include: community dental offering, Hepatitis clinics, housing and homelessness, transportation, and healthy eating. The CPM is best equipped to take information shared at the meeting and provide the populations that the organization serves with the most up-to-date information about emerging trends and topics regarding all types of health and wellness. The group meets on a monthly basis on the 1st Wednesday of each month from 12:00-1:30 PM in either Claremont or Newport or virtually via Zoom.

## Substance Misuse Prevention, Intervention, Treatment, & Recovery Contacts: Jacqui Baker & Lauren Chambers - gscphn@hitchcock.org

Greater Sullivan County 360 (GSC360) is a group of community members and professionals working together to reduce harms from alcohol and other drugs through education, policies, practices and programs related to substance misuse prevention, intervention, treatment and recovery. GSC360 serves as the PHAC's Substance Misuse workgroup. Due to an increase in youth use of vaping devices in recent years, GSC360 invested resources in decreasing this trend. Providing information is just one part of changing perceptions about how harmful drug use can be and increasing knowledge about the harmfulness of a drug is shown to decrease drug use. In fiscal year 2020, GSC360 held 9 workshops providing information about vaping on the radio twice with an overall reach of 22,000 in addition to sharing 23 social media posts on the Greater Sullivan County Public Health Network Facebook page with a reach of 714 people. In April 2020, West Central Behavioral Health began administering Medication for Opioid Use Disorder (MOUD) services at 251 Elm St. Claremont, NH providing a much needed service in Sullivan County.

This past year has been very busy for our public health emergency preparedness (PHEP) workgroup. The summer of 2019 - early 2020 the team worked to provide Hepatitis A vaccines with help from our regional partners in response to the state's declared Public Health Incident. Additionally, in September, 2019 the region collaborated with more than nine partners to hold a closed point of dispensing emergency drill that helped to advance readiness and capacity across the region in the event we needed to get medications/ vaccine to the people quickly. The spring and summer of 2020 were spent responding to COVID-19 through the setup of our Alternative Care Site, information sharing, and planning for COVID-19 vaccines among many other planning efforts. We are grateful for our PHEP partners and their dedication to the wellbeing of our communities.

# **Healthy Families**

Teach Loving Connections Family Resource Center staff continue to be working on reducing unplanned teen pregnancy through the SHINE program (Sexual Health Information Network and Education). A big project this past year was getting the SHINE Mobile, a gift through a grant from the NH Charitable Foundation, up and on the road. The idea of the SHINE Mobile is to take the message of the importance of conversation and information about sexual health throughout the communities we serve. The SHINE mobile is equipped with information that can be distributed throughout the county. It can be seen at the schools were we teach the program as well as community events like the Farmer's Markets and health fairs. The Healthy Families group also continues to provide free condoms to participating organizations and agencies.

The public health network received two grants provided by the Department of Health and Human Services and supported by the Center for Disease Control and Prevention to do planning for the reduction of lead hazard in child care centers in Claremont. The first grant was aimed at outreach to child care centers to educate early care providers on the affects of lead poisoning in children. This grant also worked to add lead education into the curriculum of the Sugar River Community College. The second grant which was awarded Spring of 2020 aims to test the water at 8 child care centers in Claremont and also provide Renovate, Repair, Paint (RRP) training to 20 individuals in the spring of 2021. These grants are working in partnership with Southwestern Community Services and the City of Claremont.

# **Health & Wellness**

The Wellness Connection Coalition (WCC) serves as the PHAC's Health & Wellness workgroup. New London Hospital is the backbone organization for the Wellness Connection. The PHAC further supports the mission and partner collaboration goals of the WCC. The Coalition strives to act as a convener for partner organizations with a focus on healthy eating, active living, stress reduction and general well-being of the community.

The continued expansion of the Fruit and Vegetable Prescription Program (FVRx) is a highlight for 2019/2020. The program is being offered with two educational programs (12-week Diabetes Prevention Program and 8-week Healthy Weight and Wellness Series) and with food insecure patients at Newport Health Center. Individuals receive a \$15 per week FVRx and families receive \$30.00 FVRx weekly to spend on fresh fruits and vegetables at seven retail partner locations (three farm stores, two farmers markets and two Demoulas Market Basket locations during the winter, spring and fall months)

# Access to Care

West Central Behavioral Health's (WCBH) Open Access model has been in place since June of 2017. WCBH has met its overall goals and has reduced and eliminated all its wait lists as of the end of 2017. From July 2019 to June 2020, 537 clients utilized Open Access and initiated their treatment with West Central Behavioral Health.

The Integrated Delivery Network (IDN) serves as the PHAC's mental health priority area. The Region 1 IDN Aligns the Greater Sullivan County workgroup in DSRIP 1115 Waiver funded projects targeting Medicaid recipients focused on Behavioral Health Integration, Expansion of Substance Use Disorder Services and Enhanced Care Coordination. The IDN strives to act as a connection for new organization collaboration in program implementation and to leverage the inter-organization relationships that are successfully delivering care across the region today. Additionally, in 2020 the IDN in partnership with the PHAC, county governance, and local partners has led Greater Sullivan Strong, a community coalition geared towards COVID-19 response in Sullivan County.

# **COVID-19 Pandemic**

When the COVID-19 global pandemic touched our region and we started to see the financial and resource struggles facing many of our partners and their clients, the Greater Sullivan Strong (GSS) Coalition and GSS Community COVID-19 Relief Fund was started.
